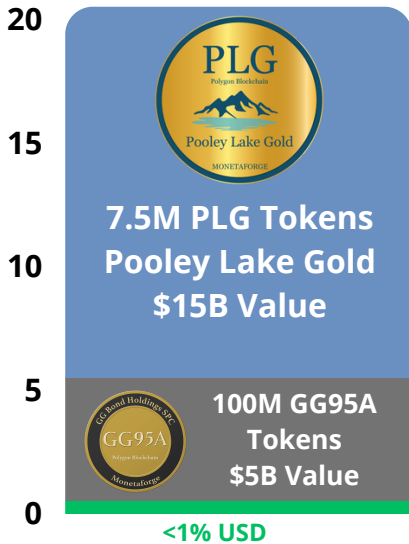

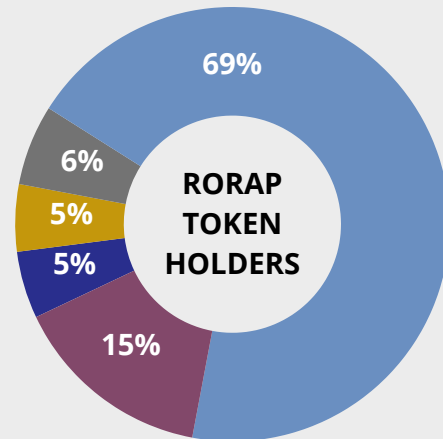
1. The portfolio will focus on high value illiquid assets for long term hold combined with cash funding placed in various trading strategies to generate cash reserves.
